### Project abstract:

The context within which apologetics is practiced is of great significance. My basic assumption is that standard accounts of apologetics suppose that the sort of intellectual questions and problems connected to the Christian faith are those which are common to the majority in the West. However, because most of these questions stem from the critical, rational, and largely atheistic Western mindset, they may fail to address difficulties that are perceived by the majority of those living in the Two-Thirds' world, for example in Ethiopia.

In the Ethiopian context, most of the intellectual challenges for Christians come from traditional religions and Islam. As a result, the existence of God and a transcendent realm hardly has to be accounted for. On the other hand, Ethiopian Christians have to face intellectual challenges which are not addressed in standard Western forms of apologetics. For example, Ethiopians often consider Christianity as the religion of one ethnic group only – in this case even the group of their colonizers. Culture and religion are unified so that for a non-Christian to accept the message of the Gospel is seen as equivalent to denying one's own nationhood and culture. The apologetical challenge here is to show how religion may transcend the boundaries of specific nations, groups, and cultures, being multi-ethnic and multi-cultural.

Hence, this project investigates to what extent current Western approaches to Christian apologetics are appropriate and effective in the contemporary Ethiopian context, and to what extent they are not. Additionally, it will explore the most prominent intellectual challenges that are specific to Ethiopian Christians and investigate what these challenges mean for the type of apologetics appropriate to Ethiopia's unique cultural setting. By doing this, we may discover how Christian apologists in Ethiopia can develop their own patterns of reasoning, true and sensitive to their own cultural context and that of the people with whom they share the Gospel.

my method will be critical analysis. I will examine approaches to Christian apologetics popular in current Western scholarly literature. I will also carry out a literary study of documents written by Ethiopian authors to figure out apologetics questions within the Ethiopian context. I will compare and contrast the apologetic questions handled by these authors with apologetic questions arising within Ethiopia, and therefore evaluate the appropriateness and effectiveness of current Western approaches to apologetics for the modern Ethiopian context.

This mainly requires comparative textual studies. Next, I will sketch the contours of a more local and contextualized apologetics by developing ways to address the main questions arising within the Ethiopian context.

### 0.3 Project summary

The context within which apologetics is practiced is of great significance. Apologetics within a Western context usually assumes that the sort of intellectual questions and problems connected to belief and unbelief will be those which are common to the majority in the West. This is for the most part correct. However, because most of the arguments in Western apologetics are aimed at the Western critical, rational, and atheistic mind, they do not address the difficulties that are perceived by the majority of those living in the Two-Thirds world, for example in Ethiopia.

My research focuses on the contextual methods of Apologetics. In doing so, I will compare and contrast the apologetic questions handled by Western authors with apologetic questions arising within Ethiopia. Therefore, I will evaluate the appropriateness and effectiveness of current Western approaches to apologetics for the modern Ethiopian context. Next, I will sketch the contours of a more local and contextualized apologetics by developing ways to address the main questions arising within the Ethiopian context. The Western presuppositions and methods may not be applicable in every case. Non-Westerners come with particular frames of reference and views of what is certain and what is not. Hence, this research investigates to explore to what extent current Western approaches to Christian apologetics are appropriate and effective in an Ethiopian context. Studying Western apologetics methods provides an essential pedagogical resource for Ethiopian apologists. It is only by studying them that we can discover to what extent Western apologetics is useful in Ethiopia and to what extent it is contextually limited to the West. It has a critical role as well.

By doing this, we might discover how Christian apologists in Ethiopia can develop their own patterns of reasoning true and sensitive to their own cultural contexts and those of the people with whom they share the Gospel.
